



## AUTHOR/S DECLARATION OF INTEREST

The *International Journal of Intangible Heritage* is determined to combat plagiarism, double publication, conflict of interest and ethical misconduct to the extent possible. Your manuscript may, therefore, be subject to review and retraction if plagiarism or conflict of interest is suspected.

The Editorial Board of the Journal thus requires that **A Declaration of Interests** must be received from all authors before an article can be accepted for publication.

All submissions to The *IJH* must conform to the International Editorial Board's uniform requirements for manuscripts submitted to the *Journal* (see Instructions for Authors).

## DEFINITION OF AUTHORSHIP

Authorship for the *Journal* is based on the following four (4) criteria:

- Substantial contributions to the conception or design of the work; or the acquisition, analysis, or interpretation of data for the work; AND
- Drafting the work or revising it critically for important intellectual content; AND
- Final approval of the version to be published; AND
- Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.

## COPYRIGHT STATEMENT

The following statements constitute the requirements to be met for confirmation of publication in the Journal:

- a) The submitted manuscript represents original research which has not been previously published, including in other languages.
- b) The submitted manuscript is not being considered for publication elsewhere ( by another publication) at this time and the authors undertake that it will not be submitted to or published in any other publication before its appearance in the *International Journal of Intangible Heritage*.
- c) The author/s have obtained/will obtain written permission from the copyright holder (usually the publisher) for all extracted text, tables, or figures planned for reproduction. [This is required even if the material is from your own previously published work.]

- d) The author/s have/will obtain permission for images or material never before published or given by another person. [Serious delays to publication can be incurred if permissions are not obtained.
